Naomi Davis, Founder and CEO, Blacks in Green



Naomi Davis is dedicated to self-sustaining Black communities everywhere. Her strategy begins with her aim to reinvent her childhood “sustainable-square-mile” here in the Age of Climate Crisis. She is the founder and CEO of [Blacks in Green \(BIG™\)](#) as well as an urban theorist, attorney, activist, and proud granddaughter of Mississippi sharecroppers. Her heritage forms the foundation for BIG’s course in Grannynomics™, The 8 Principles of Green-Village-Building™ and The Sustainable Square Mile™ which Naomi authored and teaches nationally in community lectures and workshops and at universities. Naomi serves as a bridge and catalyst among communities and their stakeholders in the design and development of green, self-sustaining, mixed-income, walkable villages within Black neighborhoods—so that every household can ultimately walk-to-work, walk-to-shop, walk-to-learn, walk-to-play—and neighbor dollars can circulate locally to help limit greenhouse gasses associated with transportation and manufacturing pollution. She conveys the risks of global warming, the health/wealth opportunities of the new green economy, the power of neighbors to lead in their city’s enviro-economic policy and practice, and the primacy of land ownership.

Eugene “Mitch” Mitchell oversees state legislative activities and advances the California utilities’ strategic policy objectives.
